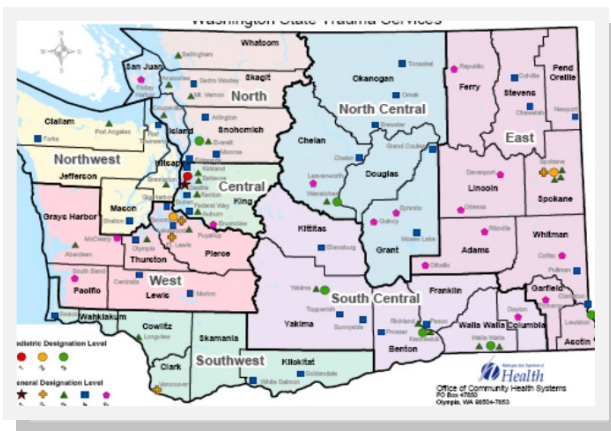


WA EMS and Trauma Act of 1990:
